Computer simulation in conjunction with medical thermography as an adjunct tool for early detection of breast cancer Eddie Y-K Ng^{*1} and NM Sudharsan²

Abstract

Background: Mathematical modelling and analysis is now accepted in the engineering design on par with experimental approaches. Computer simulations enable one to perform several 'what-if' analyses cost effectively. High speed computers and low cost of memory has helped in simulating large-scale models in a relatively shorter time frame. The possibility of extending numerical modelling in the area of breast cancer detection in conjunction with medical thermography is considered in this work.


Methods: Thermography enables one to see the temperature pattern and look for abnormality. In a thermogram there is no radiation risk as it only captures the infrared radiation from the skin and is totally painless. But, a thermogram is only a test of physiology, whereas a mammogram is a test of anatomy. It is hoped that a thermogram along with numerical modelling will serve as an adjunct tool. Presently mammogram is the 'gold-standard' in breast cancer detection. But the interpretation of a mammogram is largely dependent on the radiologist. Therefore, a thermogram that looks into the physiological changes in combination with numerical simulation performing 'what-if' analysis could act as an adjunct tool to mammography.

Results: The proposed framework suggested that it could reduce the occurrence of false-negative/ positive cases.

Conclusion: A numerical bioheat model of a female breast is developed and simulated. The results are compared with experimental results. The possibility of this method as an early detection tool is discussed.


Background


Thermography has been in extensively used as a cancer detection tool, but has not been accepted on par with mammography. One of the reasons is the incidence of high false positive cases; also a thermogram only provides a superficial abnormality whereas a mammogram provides the anatomical nature of the abnormality. However, despite this fact, patients with a false positive (abnormal) thermogram are at a higher risk of contracting breast cancer [1,2]. Keyserlingk et al. [3] observed that when a mammogram was conducted on patients with suspicious clinical examinations, the sensitivity was found to be



83%. The combination of mammogram and thermogram increased the sensitivity to 93%. When all three methods (clinical examination, mammogram and thermogram) were considered, the sensitivity was found to be 98%.

The present work is concerned with numerical modelling of a female breast, to re-look if the thermogram results can be augmented and artificial intelligence incorporated to enhance image processing, and thereby minimises the false positive results. So far, authors have numerically estimated the optimum parametric settings for tumour detection, in order to build-in robustness to the detection process by maximising the tumour signal and minimising the effect of other factors (blood perfusion, metabolic rate and environment) [4]. The numerical model of the female breast was found to agree well with experimental work by Cockburn [5]. Authors previous work [6,7] provided valuable information on the heat transfer profile across tissues and the surface temperature profile for various tumour sizes and locations. It was observed that numerical simulation,





although limited by factors such as smaller and deeper tumours, was able to capture the presence of an abnormality. However, the shape of the breast model required further improvement. The finite element grid also required better refinement and structuring. The breast may be imagined to be divided into four quadrants, designated as upper-outer quadrant (armpit), upper-inner quadrant, lower-inner quadrant and lower-outer quadrant. A more realistic model was developed and analysed [8] as compared to the hemispherical model developed earlier [7]. This model, not only had various tissue layer thicknesses, but also modelled as four quadrants. Thus the properties and parameters of the tissues in each quadrant could be changed selectively, providing better control and flexibility in the simulation. Similarly while simulating the presence of tumour the tumour volume takes the properties of tumour and that of a normal tissue while simulating a normal breast.

Methods

A three-dimensional close-actual-breast model is generated and a numerical grid with tetrahedral elements is generated. The model has four quadrants and four regions namely, skin, gland, muscle and the areola region. The computational grid is shown in (Figure 1). This model has the flexibility for changing the properties of the various layer in the various quadrant to adapt to various breast conditions and for various subjects. For example, the perfusion in the upper outer quadrant of a young lactating mother will be higher and this value can be easily adopted in the present model.

This computational model takes the material and blood perfusion properties (as given in Table 1) [9-11]. The parameter $(c_b w_b)_{1-3}$ corresponds the magnitude of various blood perfusion terms, which is the product of specific heat capacity and blood mass flow rate, k is the tissue




conductivity and q_m is the metabolic heat generated by the tissue. The simulation is performed using a CFD (computational fluid dynamics) partial differential equation cal-

culator FASTFLO (Council for Scientific and Industrial Research, Australia). The simulated thermal pattern is then compared with thermograms obtained from volun-

teers. The simulation was performed on an SGI Octane system, and the thermograms were taken using a high-resolution digital infrared camera (AVIO Thermal Video System TVS-2000 MK II ST). Thirty-four volunteers (age profile between early thirties and late forties) presented themselves for screening in a controlled environment in the pilot study in Nanyang Technological University and over 200 at the Singapore General Hospital. The imaging was taken following strict protocol [5].

Results and discussion

From the thermograms taken from the volunteers the following three cases were numerically simulated.

Volunteer #1 (38 years) with normal breasts who regularly carries out breast self-examination and undergoes annual clinical-examination.

Volunteer #2 (47 years) who had a lump in the left breast that was diagnosed as benign in 1994, and now has pain in her right breast.

Volunteer #3 (43 years) who had a benign lump removed in 1997 from her right breast. The experimental results and numerical simulations for the above three cases are presented in Figures 2 through 4. It is to be noted that a given model can be used in the computational domain by proper choice of geometric scaling factor [7]. With proper choice of scaling factor and tissue properties one model can represent several models in the physical domain.

The thermogram on the left side of a volunteer with the corresponding numerical simulation is presented (Figure 2). This volunteer undergoes regular screening by way of annual clinical examination. It can be seen she has a cold nipple region followed by a slightly warmer lower-outer quadrant (arrow A) and a warm upper quadrant, which is a standard feature for a normal thermogram. The breast base near the thoracic wall is the warmest. It can be seen that the numerical model matches the actual with appropriate choice of perfusion term.

The surface temperature of another volunteer is shown (Figure 3). This volunteer had been diagnosed with a benign lump in her left breast. She complained of pain and a lumpy feeling in her right breast. Interestingly, it can be observed that she has a relatively hot upper inner quad-

rant (arrow B). It can be seen that the relatively cool areola region (arrow A) and a hot upper breast has been simulated in the current numerical model, by appropriate choice of perfusion term.

The surface temperature on the right breast of a volunteer who had a benign lump removed near the nipple region is presented (Figure 4). It is interesting to note that this lady has a relatively cool region (arrow B) and a warm upper-outer quadrant (arrow C). Diagnosis could mistake this effect as an abnormality in the upper outer quadrant or probably a fluid collection in that region (arrow B). As it is known that the volunteer had undergone a lumpectomy, this region owing to a scar may be at a lower metabolic rate. This could be the reason that a cold spot is seen overlying that area. This analysis can be termed as 'analysis by elimination'. It is to be noted that the patient history puts to rest several misinterpretation in analysis. Just as seen in the previous two cases, here too the numerical model matches the experimental results.

Conclusions

Here it can be seen that the model is very flexible in moulding itself to the required pattern by proper choice of tissue property values, tissue thickness and geometric scaling factor. Although there exists several combinations of parameters, that would fit a particular pattern, nevertheless the simulation would help in 'analysis by elimination' where certain possibilities are eliminated. Although there exists several combinations of parameter to a particular pattern, nevertheless the simulation would help in 'analysis by elimination' where certain false possibilities are eliminated. Clinical examination by feeling the lump along with patient history, and family history might help in choosing the right parameters (i.e. model which has a lump of approximate size at some approximate location). Moreover, it is also necessary to know the length of time the lump existed, the size and history of the lump, history of surgical intervention and/or other treatment for example radiotherapy as well as the current practice of triple assessment method of clinical, ultra sound and mammography [12-14] before conclusion can be made on the imaging modality. However, the time-honoured method of using existing knowledge of specialist doctors will remain for a long time to come. As a consequence the thermogram can be a valuable risk marker and a multidisciplinary approach can bring out the best results. Thus numerical modelling in conjunction with thermogram can be an adjunct tool and not a stand-alone tool for breast cancer detection.
